**The item placed before the Governing Body was ratified.**

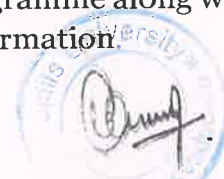
**Item No. 5: To take note on Progression of University Examinations held on May – June 2019.**

The students' performance results in the recently concluded university examinations along with the students who have become eligible for award of Degree and Diploma Certificate across the programmes was presented to members. And, the placement particulars of students who have opted for placement assistance was also presented to members for information.

**Item No. 6: To take note on University Admissions in progress and Students on Rolls at University Campus.**

The status of University Admissions for the academic session 2019-20 in progress across 6 degree programmes and one diploma programme along with current students on rolls was presented to member for information

Further, Dr. Nilanjana Bhaduri suggested that if possible to develop an App which works as a tool to prospective students and parents in obtaining necessary information about the university and programmes offered which can help them in taking a right decision for admission.

**Item No. 7: To take a note on the status update of the TeamLease Corporate University**

The status update of TeamLease Corporate University i.e., student strength across 4 classrooms and various training modules designed starting from certificate to degree level based on industrial inputs were presented to members.

Similarly, the progress made on initiatives like (i) ITI connectivity for furtherance of higher education as backward linkage, (ii) NAAC (iii) NALSOC and (iv) Shifting of NEEM Scheme to TLSU.

However, Mr. Manish Sabharwal emphasized that the initiatives like ITI connectivity, NAAC accreditation, NEEM Regulations, etc., are key to TLSU to become India's largest University in providing education and employability skills in higher education space. Therefore, it needs special focus, required attention and immediate action from respective team members to take them forward.

Further, it was suggested to prepare the presentation with required information - campus-wise Quarterly progression (students strength based on 4 classrooms, 4 qualifications), progression of quarterly financials, etc.

#### **Item No. 7: Discussion on TeamLease Corporate University**

To address the employability and up-skilling of existing workforce in corporate industry, a strategic approach proposal of (i) 4 Classrooms, and (ii) 4 Qualifications framework to partnership with corporate India being prepared to address training, development, and modular courses with academic credits that lead to a degree as mentioned below has been presented to members for their suggestions.

The 4 classrooms – Onsite, Online, On-campus and On-Job-Training provide flexibility, effectiveness and multi-model delivery to address ease of learning for workforce without leaving their jobs to part with skill development training.

The 4 qualifications - credit based Certificate, Diploma, Advanced Diploma and Degree programmes address modular qualification framework with a provision for multi-entry and exit work-based learning with academic credits and modular courses leading to a degree and its advantages for a better career progression of an employee/workforce.
